- -Due to the 2/2 split vote on agenda item D-2, Ms. Brady made a motion, at 7:03 p.m. to take a recess. Mr. Elsberry seconded the motion, and the vote was unanimous. During the recess Mr. Hosmer contacted the school district's attorney, Cory Kirby, and was advised that twice per year, due to sickness, board members can participate in a board meeting over the phone. Mr.

Hosmer was able to contact Mr. Montgomery via speaker phone.

- -At 7:12 p.m. Ms. Fletcher made a motion to return from recess. Ms. Brady seconded the motion and the vote was unanimous. Mr. Hosmer explained the situation and Mr. Elsberry verbally confirmed that Mr. Montgomery was on the speaker phone.
- -Mr. Montgomery made a motion to approve agenda item D-2 (Superintendent's recommendation to set the FY 2024 millage rate at 10.898). Ms. Fletcher seconded the motion. Mr. Elsberry, Ms. Fletcher, and Mr. Montgomery were all in favor. Ms. Lawrence and Ms. Brady opposed. Motion passed.
